Salient Changes in the revised version (2015) of ISO 14001

ISO 14001 is an internationally agreed standard that sets out the requirements for an environmental management system. It helps organizations improve their environmental performance through more efficient use of resources and reduction of waste, gaining a competitive advantage and the trust of stakeholders

The standard is based on Annex SL of the ISO Directives, a high level structure (HLS) which standardizes sub clause titles, core text, common terms and core definitions to enhance compatibility and alignment with other ISO management system standards. In addition, the revision shall consider the final report of the ISO/TC 207 SC 1 "Future Challenges for EMS" Study Group, ensure the maintenance and improvement of the basic principles of ISO 14001: 2015, and also the retention and improvement of its existing requirements

The organizations which are implementing (or are in the process of implementing) Environmental Management Systems (EMS) as per IS/ISO 14001 in their organizations require their executive at middle level or senior level trained in this area, preferably Lead Auditor for effective implementation of the system.
