- -- to plan, implement, operate, maintain and update a food safety management system aimed at providing products that, according to their intended use, are safe for the consumer,
- -- to demonstrate compliance with applicable statutory and regulatory food safety requirements,
- -- to evaluate and assess customer requirements and demonstrate conformity with those mutually agreed customer requirements that relate to food safety, in order to enhance customer satisfaction,
- -- to effectively communicate food safety issues to their suppliers, customers and relevant interested parties in the food chain.
- -- to ensure that the organization conforms to its stated food safety policy,
- -- to demonstrate such conformity to relevant interested parties, and .

## **Who Should Attend**

The organizations which are implementing (or are in the process of implementing) Food Safety Management System (FSMS) as per IS/ISO 22000 in their organizations require their executive at middle level or senior level trained in this area, preferably Lead Auditor for effective implementation of the system.
