#### ANNEX A

### **Grouping Guidelines**

1. Parliament hinges as per IS 362 are classified based on the following:

Type	Material	Size	
Type 1 - Cast	Cast brass	50 mm, 65 mm, 75 mm, 100 mm,	
Type 2 - Pressed	Mild steel, aluminium alloy	125 mm, 150 mm, 175 mm and 200	
Type 3 - Fabricated Extruded aluminium alloy		mm	

- 2. Considering the above, one sample each of the smallest and highest size from each type of Parliament hinges shall be tested to cover all sizes in that size-range for that particular type of Parliament hinges.
- 3. For Type 2, separate samples of Parliament hinges of each material (Mild steel/ aluminium alloy) shall be tested to cover that material in the scope of the licence.
- 4. The Firm shall declare the varieties of various Parliament hinges they intend to cover in the Licence. The Scope of Licence may be restricted based on the manufacturing and testing capabilities of the manufacturer.
- 5. During operation of the licence, BO shall ensure that all the varieties covered in the licence are tested in rotation to the extent possible.

### ANNEX C

## **Scheme of Inspection And Testing**

- **1. LABORATORY** A laboratory shall be maintained which shall be suitably equipped (as per the requirement given in column 2 of Table 1) and staffed, where different tests given in the specification shall be carried out in accordance with the methods given in the specification.
- **1.1** The manufacturer shall prepare a calibration plan for the test equipments.
- **2. TEST RECORDS** The manufacturer shall maintain test records for the tests carried out to establish conformity.
- **3. LABELLING AND MARKING** As per the requirement of IS 362:1991.
- 3.1 **PACKING** Packing of hinges bolts shall be done as per clause 9 of IS 362:1991.
- **4. LEVELS OF CONTROL** The tests as indicated in column 1 of Table 1 and the levels of control in column 3 of Table 1, shall be carried out on the whole production of the factory which is covered by this plan and appropriate records maintained in accordance with paragraph 2 above.
- **4.1** All the production which conforms to the Indian Standards and covered by the licence should be marked with Standard Mark.
- **5. REJECTIONS** Disposal of non-conforming product shall be done in such a way so as to ensure that there is no violation of provisions of BIS Act, 2016.
