Introduction

Bureau of Indian Standards operates various Conformity Assessment Schemes, providing third party assurance on safety and quality. As per the terms and conditions the Schemes, the BIS licensee is required to engage qualified Quality Control Personnel, who are responsible for maintaining quality control checks including testing of product and maintenance of quality records.

Lack of technical expertise of the Quality Control Personnel has been pointed out as one of the constraints faced by the Industry while obtaining/operating BIS licences.

This gap is increasing with many new products coming under mandatory BIS certification. Hence, a need was felt to provide education in various testing fields to increase the availability of competent workforce.

Government of India programs such as “Make in India” and “Skill India” also are expected to open tremendous employment avenues for quality control personnel in production and process industry.



Objectives

- Bridge the competence gap in the skills of quality control and testing personnel
- Make participants skilled enough to be employed as Quality Control personnel in production and process industry for achieving quality as per prescribed standards.



Courses


Courses will be held for the following fields of testing –

- a) Chemical
- b) Microbiological
- c) Mechanical
- d) Electrical



Course duration


Each course will be a Non-residential course of 4 weeks (combination of theory and practical classes).





Who should attend?

- Persons wanting to update/gain comprehensive knowledge of the testing of various products and make a career in related fields.
- Quality Control personnel already working in BIS licenses units for skill development/updation.

Criteria for selection & batch size

- Diploma/Graduate in related science/engineering subjects
- Batch size - 20.
- Selection on First come First serve basis



Venues

The course will be run by NITS, Noida with venues at BIS offices and BIS/Recognized laboratories. Hostel facilities at NITS, Noida can be availed on payment basis for courses run at Central Laboratory, Sahibabad.



Course Fee


Course Fee is Rs. 10,000/- plus GST (@18%) to be paid online through the BIS Training Portal or through NEFT to **“Bureau of Indian Standards, Savings A/c No. 712210100000650, Bank of India, Sector-62 Noida, Branch Code 7122, IFSC Code BKID0007122.”**



Assessment

Continual assessment will be done throughout the course duration through unit tests and final examination (theory and practical both).

Successful candidates can later also attend short duration (2-3 days) courses for product specific testing.
