Subject: Extension of the period of concurrent running of IS 3745: 2006 and IS 3745: 2024-"Yoke Type Medical Cylinder Valve with Pin index Connection"

This has reference to the subject mentioned above.

IS 3745: 2006 was revised as IS 3745: 2024. The guidelines for implementation of the above-mentioned revision was circulated vide note no. CMD-3/16: IS 3745 dated 31 December 2024. The last date of implementation of the revised Standard was 14 April 2025.

In view of the requests received from manufacturers, the concurrent running of IS 3745: 2006 and IS 3745: 2024 and the last date of implementation of IS 3745: 2024 has now been extended up to **14 April 2026**. All BOs may bring it to the notice of all Licensees and Applicants and ensure implementation of revised Standard by 14 April 2026.

The other provisions of implementation laid down in circular no. CMD-3/16: IS 3745 dated 31 December 2024 shall remain the same.
