JUDGMENT

The above complaint is filed by the complainant against the accused for offence punishable u/s. 34(1) of Bureau of Indian Standards Act.

2. Accused Nos. 1 to 3 & 5 absent applied. Copies of prosecution records were furnished to the counsel for the accused persons. When the particulars of offence was read over and explained to the counsel, accused pleaded guilty through the counsel. Plea is found to be voluntary in nature and the same is accepted

4. Accuse No.s 1 to 3 & 5 are convicted for offence u/s. 34(1) ~~34(1)~~ of Bureau of Indian Standards Act sentenced to pay a fine @ Rs.8,000/- each u/s. 34(1) of Bureau of Indian Standards Act. and in default of payment of fine, accused shall undergo Simple Imprisonment for a period of 10 days each. Case against Accused No.4 is refiled as S.T. 02/2016.
