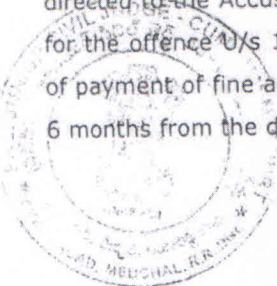

**ORDER**

Considering the same by taking the lenient view and voluntarily pleaded guilty by the Accused No. 1 to 3 for the offence U/S. 11(2) R/w 33 of the Bureau of Indian Standards Act, without licence directed to the Accused No. 1 to 3 are to pay the fine amount of Rs. 50,000/- each for the offence U/s 11(2) R/w 33 of the Bureau of Indian Standards Act, in default of payment of fine amount. They shall undergo simple imprisonment for a period of 6 months from the date of this order.

Further directed to the complainant i.e., Bureau of Indian Standards shall destroy the seized property i.e., Sl. No. 1 & 2 and forfeit the same to the Bureau of Indian Standards. The S.No.3 & 4 of case property shall returned to the A2 and shall submit the distruction panchanama report before this Honourable Court with in one month from the date of this orders.
