### **Significance of IS/ISO 17025 based Laboratory Quality management Systems**

- It specifies the general requirements for the competence to carry out tests and/or calibrations, including sampling.
- It covers testing and calibration performed using standard methods, non-standard methods, and laboratory-developed methods.
- Applicable to all organizations performing tests and/or calibrations. Including, for example, first-, second- and third-party laboratories, and laboratories where testing and/or calibration forms part of inspection and product certification.

The organizations which are implementing (or are in the process of implementing) LABORATORY QUALITY MANAGEMENT SYSTEMS (LQMS) as per IS/ISO 17025 in their organizations require their executive at middle level or senior level trained in this area, preferably Lead Auditor for effective implementation of the system.
