Sub: Implementation of the recommendation of 7th CPC- Option regarding Commutation of Additional Amount of Pension

1. This has reference to the Ministry of Personnel, PG & Pensions (Department of Pension & Pensioners Welfare) notification No. F.No. 41/14/2016-P&PW(G) dated 24th October, 2016 on the subject mentioned above. This notification relaxed the provision of Rule 10 of CCS(Commutation of Pension) Rule, 1981, and gives the pensioners an option for not to commute the pension which has become additionally commutable on revision of pay/pension on implementation of recommendation of the 7th CPC.
2. In view of the above, only those pensioners, who had retired from BIS services after 01.01.2016 and **do not want additional commutation**, are requested to submit an undertaking in the enclosed proforma to Finance Department, BIS latest by **15th March 2017**. The option, once exercised, shall be final.
3. In case the option is not received by **15th March 2017**, the Finance Department will commute the pension which has become additionally commutable on revision of the pay/pension on implementation of the 7th CPC. Accordingly, the pensioner will be paid the difference between the commuted value determined with reference to enhanced pension and commuted value already paid.
4. Those Pensioners (retired after 01.01.2016) who want additional commutation, need not respond.
