Expression of Interest (EOI) for Setting up Assaying & Hallmarking Centre under the Central Assistance Scheme

1. Bureau of Indian Standards (BIS) invites applications from Central/State Government/ PSUs/Laboratories of repute in Public/Private sector/private entrepreneurs and other interested parties, eliciting ‘**Expression of Interest**’ for ‘**Setting up of Gold Assaying and Hallmarking Centre**’ during 2020-21 and obtaining Central Assistance. The Assaying & Hallmarking (A&H) Centre shall be set up in any District in India where no such A&H Centre exists.
2. Under the scheme entrepreneurs will be given one time financial assistance, the rates of which are given below:

| Area | Rate (% of the total cost of machinery and equipment given to A&H Centre as assistance) | |

| Normal | 30% | 50% |
| NE/SCS/RA | 50% | 75% |

NE – North East States, SCS - Special Category States, RA – Rural Areas
(Municipal Acts concerned will be the basis for definition and identification of rural areas)

3. The applicant who sets up a Centre at any District where no such centre exists complying with the [Terms and Conditions](#) and who first obtains recognition by BIS will be eligible for the financial assistance. The list of existing assaying & hallmarking centres in the country is available on the BIS website www.bis.gov.in, however for easy access the link is as given below: <https://bis.gov.in/index.php/hallmarking-overview/hallmarking-centre/list-of-hallmarking-centres/>),.
All other centres even if they do not get the financial assistance, will be entitled to recognition by BIS as Assaying & Hallmarking Centre, if found fulfilling the prescribed requirements.
4. A centre selected for central assistance, shall be required to operate as BIS Recognized Assaying and Hallmarking Centre under BIS Hallmarking Scheme. For details of [BIS Hallmarking Scheme](#) please visit our BIS Website: www.bis.gov.in .
5. The applicant centre or its promoters shall not have any linkage with Jewellery trade or manufacturing.

7. Application shall be accompanied with an Application-cum-Processing Fee of Rs 1000/- (Rupees One Thousand) plus GST, as applicable).
