# LIST OF PROVISIONALLY SELECTED CANDIDATES FOR APPOINTMENT TO THE POST OF SCIENTIST-B

Based on the Score of Graduate Aptitude Test in Engineering (GATE) and further interviewconducted by the Bureau of Indian Standards, New Delhi, during 18 August 2021 to 03 September 2021, the list of candidates who are provisionally shortlisted forappointment to the post of Scientist B at the initial basic pay of Rs.56,100/- per month in the Level -10 as per 7<sup>th</sup> Central Pay Commission (CPC) Pay Matrix, is given below. In addition to pay, he/she will be entitled to the usual allowances as admissible under the rules of the Bureau in force from time to time.

- 2. A separate offer of appointment letter will be issued to the selected candidates as listed below at their registered email id only. The offer of appointment is provisional and is subject to:
  - i) Production of Medical Certificate of fitness issued by the prescribed Medical Board in the required proforma on or before the date of joining but in any case, not later than three months from date of joining.
  - Verification of Caste Certificate through proper channels not later than six months from date of joining. If the verification reveals that the claim of the candidate belonging to SC/ST/OBC (including belonging to non-creamy layer)/ EWS/PwBD is false, the services of such candidates will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
  - Production of Original Certificates and Testimonials along with their photostat copies, duly self attested, relating to his/her date of birth, educational qualifications, degree, marks-sheet, experience, GATE Scorecard and caste certificate in case of SC/ST/OBC/EWS/PwBD candidate etc., as entered in original application.
  - iv) Production of Relieving/Release order from his/her present employer, if any.
  - v) Antecedent clearance by appropriate authority not later than six months from date of joining.
  - vi) No person who has entered into, or contracted a marriage with a person having a spouse living, or who having a spouse living has entered into, or contracted a marriage with any person, shall be eligible for appointment to any post.
- 3. He/She shall intimate the undersigned within 07 days, whether or not, he/she accepts offer of appointment. If he/she accepts the offer,he/she should report for joining duty (&Induction Training) at the following address on 25<sup>th</sup> SEPTEMBER 2021 at 09:00 am:

- 4. At the time of reporting for duty, he/she must produce:
  - a) Original Certificates and Testimonials along with their Photostat copies relating to his/her date of birth, educational qualifications, degree, marks-sheet, experience and caste certificate in case of SC/ST/OBC/PwBD candidates (along with noncreamy layer status the date of issue of which shall not be older than three years )/ EWS etc., as entered in his original application;
  - b) Relieving/Release order from his/her present employer, if any;
  - c) Two copies of his/her recent coloured photograph strictly of the size of 2cm x 3cm;
  - d) Attestation Form, Identity Certificate and Declaration Form duly completed in all respects in the required proforma, which will be sent alongwith offer of appointment letter.
  - e) Home Town Declaration in the required format, which will be sent alongwith offer of appointment letter.
  - f) Declaration regarding proficiency/working knowledge in Hindi, in duplicate, in the required proforma, which will be sent alongwith offer of appointment letter.
  - g) Surety bond along with a surety on a non-judicial stamp paper of Rs.100.00 in the format, which will be sent along with offer of appointment letter.
- 5. **Precautions/ Guidelines in view of COVID-19:** The candidates may keep note of the following important guidelines/ precautions which are necessary to be observed in view of situation due to COVID-19:
  - a) Candidates are required to bring their Covid negative report issued not more than 72 hrs prior to the date of joining.
  - b) Wearing of face masks is compulsory at time of joining, training class and while in public place/ area. Aarogya Setu App shall be installed on the mobile phone.
  - c) Social Distancing norms shall be followed at all times during the tenure of the induction training. Social distancing norms will be followed for seating arrangement in the training lecture hall.
  - d) Single room accommodation will be provided for the duration of Induction Training. The candidates are advised to come for joining/ training alone without any accompanying person/ parent/ guardian.
  - e) Thermal Scanning will be done at entry of Training Institute premises.
  - f) In case if he/she is presently under quarantine/tested positive for COVID-19/ having symptoms of COVID-19, it is advised that candidate may seek extension in joining.
  - g) The relevant guidelines issued by Ministry of Home Affairs, Government of India and appropriate Authorities, from time to time, shall be followed.
